

SZUTEST **CONFIDENTIALITY AND IMPARTIALITY COMMITMENT** **(TOP MANAGEMENT)**

I undertake;

To treat all persons/organizations around the world requesting services equally, integrity and impartially in all circumstances, regardless of geographical location, size, and associations or organizations to which they are members,

To ensure that the personnel involved in conformity assessment activities provide reliable services based on objective data, away from any commercial, financial and other pressure, without being exposed to pressure from any party, without considering the interests of individuals/organizations,

To fully and completely fulfill my duties in case of possible conflicts of interest analyzed to ensure that the principles of impartiality, integrity and independence are fully complied with,

Not to assign the personnel involved in conformity assessment activities in the decision mechanisms in accordance with the national and international standards, laws, regulations and legislative requirements regarding accreditation, notification, and authorization,

Not to have any positive or negative influence on the personnel (internal and external) assigned in the conformity assessment decision process, to ensure that the conformity assessment process is terminated when a situation that will affect their impartiality is detected,

To refrain from any behavior that may damage the reputation of the persons/organizations served, provided that I adhere to the SZUTEST documents created within the framework of national and international standards and legislative requirements, which are the basis of accreditation, notification, and authorization,

To ensure the protection of confidential information and property rights that I have obtained in conformity assessment services given to persons/organizations,

To abide by the impartiality, integrity, independence, confidentiality, and ethical rules by publicly planning and announcing activities to the relevant parties such as seminars, conferences, training, etc., which are carried out or planned to be continued as a side activity in case of need, apart from the services provided to individuals/organizations,

To carry out all conformity assessment activities with competent personnel in a transparent manner based on the principles of independence, impartiality, integrity, and confidentiality,

To fulfill my duties in my area of responsibility for the services carried out within the framework of SZUTEST Accreditation, notification, and authorities,

Not to engage in any activity that would conflict with the independence of decisions and assessments regarding SZUTEST activities, that I am not the designer, manufacturer, supplier, installer, commercial purchaser/user, owner, consultant or maintainer of the products evaluated for compliance, nor the owner, authorized representative and partner of these parties.

That I am not directly related to the products subject to conformity assessment and other products (such as a competitor brand or manufacturer) in competition with the products,

Within the scope of SZUTEST activities, not to engage in any activity that is thought to affect my impartiality in other department activities in my area of responsibility,

Not to engage in any activity that may cause a conflict of interest and impartiality with other companies owned by SZUTEST partners,

To abide by the rules and rules in FR.10 Confidentiality and Impartiality Commitment.
