Method for collecting personal data

Your personal data is obtained in the following ways, by either fully or partially automatic means or by non-automatic means, provided that they are part of the data recording system, by our Company or through third party business partners from whom our Company receives service.

Your personal data is obtained by;

- (1) Filling the application form on the company website
- (2) Filling out the contact form on the website
- (3) Logging into company-owned platforms
- (4) Automatically through cookies, if the website is visited

Purposes of processing your personal data and legal reason

Your personal data is obtained and processed within the scope of the following purposes and legal reasons in order to serve you better.

- If you communicate with our company, your identity and contact information within the scope of our Company's legitimate interests, pursuant to Article 5/2-f of the PDPL, in the execution of communication activities, in the follow-up of requests/complaints,
- During website visits, transaction security information is obtained and processed in accordance with the legitimate interests of the company in accordance with Article 5/2-f of the PDPL.
- In order to inform about the purchased goods and services,
- Commercial electronic messages for the purpose of informing you about advertisements and campaigns can only be sent in accordance with article 5/1 of the PDPL, if you give your consent through the Message Management System (İYS), as regulated in article 5, with the exception of your explicit consent and the exceptions in article 6 of the Regulation on Commercial Communication and Commercial Electronic Messages numbered 6563.

If you communicate with WHATSAPP, your personal data is processed for the purpose of carrying out communication activities. If you send a message to our Company through the application called WHATSAPP, your personal data is obtained and processed within the scope of your explicit consent in accordance with Article 5/1 of the PDPL. Your personal data is obtained automatically through the WHATSAPP application.

Important Note: Due to the use of foreign service providers in communications via WHATSAPP, your personal data may be sent abroad and may pose a risk to the security of your information. For the security of your personal data, we recommend that you contact us via our corporate e-mail address.

To whom and for what purpose personal data can be transferred

Your processed personal data can be transferred, in accordance with the above purposes and the conditions in Articles 8 and 9 of the PDPL, by obtaining explicit consent in cases where explicit consent is required by law, and in cases where it is mandatory within the framework of the conditions determined by the law, and to the extent necessary;

- (1) To authorized public institutions and organizations within the scope of the obligations of the Law,
- (2) To the consultant lawyer, judicial and administrative authorities within the scope of the follow-up and execution of legal affairs,
- (3) Within the scope of your explicit consent, pursuant to Article 9/1 of the PDPL, to the overseas service providers from which we receive IT services (web hosting, corporate mail, etc.),

(4) If you give your consent to send commercial electronic messages, your personal data can be transferred to foreign service providers within the scope of your express consent in accordance with Article 9/1 of the PDPL.

Your personal data obtained through WHATSAPP is sent to authorized public institutions and organizations in order that it is mandatory for the Data controller to fulfill its legal obligations, to judicial and administrative authorities for the follow-up and execution of legal affairs, and it can be transferred abroad since the headquarters of the WHATSAPP Inc. company is abroad (United States) within the scope of your explicit consent in accordance with Article 9/1 of the PDPL.

Other rights of the related person as listed in Article 11

Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
