- 3. Fee information regarding the relevant Certification Program is published on $\underline{www.szutest.com.tr}$.

- 5. Fee will not be returned in case you give up and do not take the exam for various reasons or in the cases of suspended or cancelled certificates.
- 6. Personnel certification process will be carried out as per international standards, national competencies, codes and SZUTEST procedures.
- 7. If a practical exam is to be held, details regarding exam conditions and test parts will be learned from SZUTEST depending on the program to be applied.
- 8. Scope of the certificate to be required will be expressed clearly by the applicant.
- 9. All required information for evaluation in personnel certification will be provided. If necessary, documents proving and supporting the relevant characteristics will also be provided.
- 10. The candidate must be literate.
- 11. The location and order for the personnel exam shall be provided by the applicant.
- 12. Test parts to be used during the exam will be prepared by the applicant as per, if any, the relevant standards.
- 13. Machines, equipment and other tools to be used during the exam will be provided by the applicant and the candidate must guarantee that such machines and equipment do not affect the result of the exam.
- 14. Applicant will be responsible for taking the measures regarding the occupational safety and preparing a safe exam environment during the personnel exam. Exam will not be started unless appropriate conditions are provided.
- 15. For the examinations to be held on the basis of national competencies, equipment to be required for the occupational safety of the candidate will be provided by SZUTEST. Candidate must use such equipment during the examination.
- 16. The employee as being the candidate for certification will take the exam only on behalf of himself/herself.
- 17. Test fees of the examination samples will be paid by the applicant unless otherwise is stated.
- 18. In the event that the location for the examination, test parts, equipment and tools to be used during the exam cannot be provided by the applicant, examination will be held in a location to be determined by SZUTESt.
- 19. In the event that the information provided to SZUTEST is not correct, the certificate will be suspended or cancelled by SZUTEST.
- 20. Candidate must avoid dangerous behaviors in the field of the examination.
- 21. Candidate will not share the information acquired during the examination and regarding the examination materials (examination questions, material properties, etc.) with $3^{\rm rd}$ Parties.
- 22. Candidate will not cheat and avoid fraudulent conducts during the examination.

DOCUMENT USAGE CONTRACT

- 23. Candidate will cover the damages if s/he deliberately gives damage to the examination materials.
- 24. The person who has applied for certification will be entitled to raise all complaints and objections regarding certification to SZUTEST at the end of the examination or certification.
- 25. Certificates permitted by the relevant certification standard and for which the required conditions are met will be able to be renewed.
- 26. In case of any change in certification conditions (change in the scope of certification, etc.), related parties will be informed by www.szutest.com.; certificate holder is responsible for following the status of the certificate over this website.
- 27. Once the validity period of the certificates expires, the method to be used for recertification will comply with the certification procedure for the first time if such method is not set forth in the certification standard. If this issue is mentioned in the certification standard and the conditions are met as per the certification standard, recertification will be carried out.

- 29. Measurements and evaluations carried out within the scope of Professional Competence are recorded by camera.

Candidate's Liabilities:
